

- 1. Recognition Renewal of the school as per the rules framed under the acts of Karnataka Education Act 1983 and Right of Children Education Act 2009, rules framed and renew, the accreditation for the registered classes. Apart from these classes, additional classes and additional sections are not permitted.
- 2. School should work as per the rules framed under the acts of Karnataka Education Act 1983 and Right of Children Education Act 2009
- 3. Reservation of 2.5 per cent seats for children from weaker sections under the rules framed under the Child Rights Act, 2009. (Government has framed rules to facilitate enrolment of children in neighbouring schools where their parents live, according to which, if there are government, government-aided educational institutions, children chould be enrolled in those schools) Schools covered by RTE will have the authority to RNAGENDRARTOL the reserved seats under RTE, otherwise private schools will enrol children and allow them to continue their education up to the Remanagera Disprimary level. To enable these children to pursue education without any discrimination. Reg. No. 12405

- 4. As described in Section 3, the fee of children enrolled under RTE rules is released by the Government as per rules. Hence School / Governing Body has stopped from charging any fees from these children.
- 5. The school and the school management have prohibited any form of capitation fee and voluntary donations from parents either at the time of enrolment or later.
- 6. The information of fees charged by the school / governing body as tuition fee from the parents of their school children is provided by the State Govt. Order No. ED31: PGC: 2019, dated: 27/07/2019 Publication of application information on departmental website and school notice board. No additional fee shall be charged over and above the fixed fee.
- 7. The School/Managing Board shall enrol the students within the period prescribed by the Government
- 8. The School / Governing Body cannot refuse enrolment against the following factors
  - (i) Due to lack of proof of age
  - (ii) Based on caste, religion, place of birth, language
  - (iii) If admission is sought after extended period of admission
- 9. Taking safety measures as per RTE Act and Rules, Karnataka Education Act and Rules (Fire safety and building safety certificate from concerned authorities and child learning safety as per KSCPCR and NCPCR)
- 10. School / Governing Body as follows

(i) No admitted child shall be retained in any class or expelled from the school till he completes primary education and secondary education in the school.

(ii) No child should be subjected to physical or mental abuse

(iii) No child is required to pass any board examination till completion of primary education

(iv) Every child who completes primary education is issued a certificate as prescribed under Rule 21 of RTE and Karnataka Education Act and Rules.

(v) As per the provisions of RTE Act and Rules and Karnataka Education Act and Rules **AR** be school should also include children with special needs/special children.

(vi) Appointed teachers should possess minimum qualifications as prescribed for RNAGENDR primary and high school teachers in RTE Act and Rules and Karnataka Education Act and Rules and Government Orders.

> (vii) Salaries and allowances payable to teachers and terms and conditions of service shall be as prescribed by the State Government. And salaries are paid to teachers

(viii) Teachers shall perform the duties prescribed under Section 24(1) of the Act and the RTE Act and Rules and Rule 17 of the Karnataka Education Act and Rules and shall not engage themselves in private tuitions for supervisory consideration.

- 11. Following the academic State curriculum and state text books to which the school is affiliated
- 12. To maintain school norms and standards as specified in Karnataka Education Act 19. Appointment of departmental staff as prescribed in the Karnataka Education Act and Rules
- 13. School buildings and other infrastructure related to the school should not be given over to any commercial activities or political and non-educational activities day and night.
- 14. The school should not be given to any person or group or association for profit
- 15. Get the school audited by CA and submit the copy by the end of June every year
- 16. Following the School Language Policy as per Government Notification (Kannada Language Policy 2016).
- 17. The management board and teachers will function as per RTE ACT 2009 and Karnataka Education Act and Rules.
- 18. The school / governing body must follow the rules and directives of the government and the department without fail
- 19. School information in SATS should be updated as per rules by the end of March every year
- 20. Violation of the above conditions will result in cancellation of recognition/accreditation of the school as per the rules framed under the RTI ACT 2009 and the Karnataka Education Act.
- 21. After the completion of school accreditation, the entire document/information in the application submitted online by the governing body is enabled to be viewed publicly on the departmental website.
- 22. Violation of the above conditions will result in cancellation of accreditation of the school as per the rules framed under the RTI ACT 2009 and the Karnataka Education Act.


